Eligibility is primarily based on free and reduced lunch eligibility; however, if a family is not eligible for free or reduced lunch, we will take into consideration other factors, such as family member illness, special needs, etc. A letter is mailed to the parents letting them know about the decision, with instructions on how to register for camp, and how much they will be required to pay.
